

ITEMS TO INCLUDE IN A SEED SCOUT LEGAL AGREEMENT

Payment Schedule

- **For clinics with a quarantine period:** 1/3 payment within 1 business day of first donation, 1/3 payment within 1 business day of last donation, 1/3 payment within 1 business day of receipt of the post-quarantine blood test results.
- **For clinics without a quarantine period:** 1/2 payment within 1 business day of the first donation, 1/2 payment within 1 business day of the last donation.
- Payments should be made via Venmo or a similar platform.
- Last payment is only due if donor's STI panel and CMV IGM test comes back negative. In case of a positive STI panel that makes it so the clients cant use the sperm, the donor will redonate for no extra charge.

Donations

- Donor only has to donate up to 4 times in one week. If there are any other donations agreed to by the parties, more compensation must be provided. We suggest at least \$250 per donation.
- Donor must have a blood test done at the end of a quarantine period (if applicable).
- The intended parent(s) is/are not restricted in how many kids they can have with those donations. Extra vials of sperm or extra embryos cannot be donated or sold to other people.
- Donations to science are not permitted.

Intended Parent(s)' Requirements

- Intended parent(s) must alert donor of any pregnancies (within 2 months of positive test).
- Intended parent(s) must alert donor of any births (within 1 month of the birth).
- Intended parent(s) must provide at least a yearly update about kids with photo until age 18 unless donor temporarily opts out for any reason. If donor opts out of updates, they can always opt back in at a later date.
- The intended parent(s) must alert donor if their contact information changes.

Donor's Requirements

- Upon yearly request from client, donor must provide an update about their family medical history (if any changes have occurred).
- The donor must alert the intended parent(s) if their contact information changes.
- Donor must agree that their identity will be known by the children and must agree to be reasonably accessible to children for at least the first two contact attempts by each child to answer their questions.
- Donor's sexual or travel activities should not be restricted for more than 2 weeks before donations and their substance or tattoo activities should not be restricted for more than 4 weeks before donations.

Future Donations

- The donor will donate to no more than 3 families through Seed Scout.
- The donor will not donate to recipients outside of the Company other than to close friends (someone they were friends with for at least a year before the topic of sperm donation came up between them) or family.
- This restriction includes donating to a sperm bank or cryobank, or to families the Donor meets through services including, but not limited to, sperm matchmaking companies, family creating applications, or social media groups.
- The donor will alert the intended parent(s) about any other donations and about any births from those donations.

Privacy

- Both parties agree not to disclose the identity of the other party on social media or the internet without the written permission of the other party.

Parties

- If applicable: Both parents (biological and non-biological) as well as the donor, must be parties to the agreement.
